



Sustainable BNE Festival Promotional Terms

Win 1 of 8 Event Day Experiences Promotion Terms & Conditions

1. These terms and conditions set out all the information regarding the Win 1 of 8 Event Day Experiences promotion as part of the 2026 Sustainable BNE Festival. (the Terms and Conditions).
2. The Promoter of the competition is Brisbane Sustainability Agency ACN 099 480 010 of Level 20, 307 Queen St, Brisbane Qld 4000. Telephone number 07 3007 7000 (the Promoter).
3. Information on how to enter this competition forms part of these Terms and Conditions.
4. Competition entry is deemed acceptance of these Terms and Conditions.
5. Prize: There are eight (8) individual prizes to be won. Each prize is an event day experience pack consisting of a picnic box for two valued at \$70, plus a Parklands Highlights Tour and native plant. The stated individual prize value is \$80. The total prize pool is \$640.
6. The prize is not exchangeable or transferable and cannot be redeemed for cash. Any additional expenses incurred by prize winners are the responsibility of the prize winners.
7. Unless otherwise expressly stated, the prize value is based upon the recommended retail prices at the time of first publication of these Terms and Conditions. The Promoter accepts no responsibility for any change in prize value between publication and redemption.
8. Competition period: This competition will commence on Monday 27 April 2026 and close on Wednesday 20 May 2026 at 9:00am AEST. No entries submitted after this time will be eligible to win a prize.
9. How to enter: Entrants may enter the competition by clicking "Going" or otherwise RSVP'ing to the official Sustainable BNE Festival Facebook event page during the competition period. Each eligible RSVP will go into the draw to win.
10. Only one entry per entrant will be accepted. Multiple entries submitted by the same person may be deemed invalid at the Promoter's discretion.
11. Eligibility: To be eligible to enter this competition, a person must:
 - a. complete the required RSVP action on the official Festival Facebook event page during the competition period; and
 - b. not be an employee or immediate family member of the Promoter.
12. Competition draw: The eight (8) winners of the competition will be the first eight eligible entries randomly drawn by an officer of the Promoter at 10:00am AEST on Wednesday 20 May 2026. The decision of that officer will be conclusive, and no correspondence will be entered into.
